I'd like to first thank the Board of Supervisors for giving me the opportunity to serve as Township Manager. It's been six months now and I am still learning new things and discovering new challenges and issues. One thing is clear to me, the residents, and all our talented volunteers who serve on committees, have been instrumental in helping me understand the rich history of Chadds Ford Township.

One very important project that will be underway in 2023 is Walkable Chadds Ford (WCF). What is the purpose of WCF and why is it important? The Chadds Ford Village is a critical commercial area known for its commerce, culture, tourism, and housing. Yet, the challenge for planners is how to retain its charm while dealing with vehicles and trucks speeding through that area. How will WCF attempt to solve the disconnect with all of these assets in the Village combined with high speeding on Route 1? In summary, WCF will have trails, sidewalks, traffic calming and site amenities that will address the current challenges in the Village while strengthening the historic sense of place for the Village.

Another important project, and one that has been worked on for a very long time, is the Township's Zoning Code update. Why is this important? The basis for a Township's vision on how it wants to see and manage growth is the Comprehensive Plan. Our Plan, which was adopted in 2017, is an excellent example of policies that the Board of Supervisors adopted to guide growth in a smart and sensible way. A key piece missing is matching, to the extent possible, zoning code language to further align with the policies in the Plan. This will help give guidance to developers, the Planning Commission, and the Board of Supervisors. We hope to have this adopted in early 2023.

In summary, it's my pleasure to serve the residents of Chadds Ford. I have been in public service now for 20 years, and I look forward to addressing issues in a collaborative and meaningful way.



#### Seasonal Tips & Reminders

Indian Summer was lovely this year and Autumn laves were simply stunning to enjoy, while they were still on trees. Now that most of the leaves have fallen, we're all busy clearing them off our lawns. The Township encourages composting your leaves, either in a bin or container built for composting, or simply by moving the leaves into an unused corner of your yard to begin decomposing. Leaf compost is one of the best mulches we can add to our gardens any time of year, and making it is simple. Chopping the leaves as we gather them by riding over them with our lawnmowers speeds up the process of turning leaves into mulch. If you do compost leaves and garden debris on your property, remember not to put in any kitchen waste other than fruit or vegetable peels, egg shells, tea bags and coffee grounds. No food stuffs should be placed in your compost pile. Turning your pile, layering green materials with the leaves, and watering it once a month if it hasn't rained will also help with turning leaves into mulch.

Remember when cleaning up your property this autumn to contact the Township for information if you need to burn sticks and debris. It is not generally acceptable to burn leaves, as they smoke rather than ignite, causing bothersome conditions and pollution. As you work around your trees, look at the health of the tree, and make sure to make note of dead or hanging branches that could fall from the tree. Check vegetation around your driveway to be certain folks entering and leaving your property can clearly see traffic before entering the roadway, or obstacles that may be in your driveway but hidden from view.

Fall is always a good time to inspect your Smoke Detectors and Fire Extinguishers. If you have young children living at home, try to involve them with a regular safety check of your home, and discuss evacuation drills if you should find the need to leave your home immediately. It's also always a good idea to have a working flash light handy in various locations throughout your home, as storms and high winds in our area do interfere with power at times. Be safe, and prepared for the unexpected in your home and on your property as we move into the busy holiday season ahead.

## Winter Weather Tips and Best Practices

As the seasons change from Fall to Winter, remember these tips in order to avoid dangerous winter travel situations:

- Check your car's radiator system and have it serviced as needed.
- Check the antifreeze in your car to make sure you have the right amount and mixture.
- Check your windshield wiper blades and replace your wiper washing fluid with one specifically for the Winter season.
- Check your tires for any worn-down areas or treads.
- Be sure to always have an ice removal tool in your car when traveling during the Winter.
- Stay on main roads and highways. Avoid hills and roads with sloping surfaces wherever possible.
- Avoid driving at night or alone if possible.
- Keep blankets and bottled water in your car should you become stranded.
- Before going out inform at least one family member or friend where you're going and when you plan to return.
- If a snowstorm or blizzard forces you to stop, pull off the highway and turn on your hazard lights. If you have a distress flag or sticker, hang it from your radio antenna or apply it to your window. Remain in your car.
- If you become stranded for an extended period of time, run your engine for 10 minutes every hour to stay warm. Open a window slightly for ventilation while the car is running, to prevent any carbon monoxide buildup and remove any snow that builds up on your car's exhaust pipe.
- If you need to spend the night in your car, turn on the interior overhead light so rescuers or work crews can see you.


## How to Change Your Mailing Address if You Are Not Receiving Tax Bills

Over the past two years the Township has seen a number of property owners who have not received real estate tax bills due to an inaccurate mailing address. Delaware County maintains the property database for all three taxing authorities (County, Township, and School District) and each taxing authority uses the database the County provides to print and mail your annual real estate tax bills. If your mailing address was incorrect last year, there is a form you can fill out and submit to the County Assessment Office. <u>The form is available on Delaware County's</u> website.

Follow the instructions to return the completed form to the County Board of Assessment Office. One of the forms requires a folio number which can be found on the top right corner of your Township tax bill or any of your tax bills. In order for a change to take place on your 2023 tax bills, return a completed form to the County by mid-December.

Tax that contributes to our efforts; however the tax amount collected is a small drop in the bucket toward the cost of acquiring and maintaining open space. We can in some instances ask developers to contribute toward our Open Space Fund and this does help. We are also very aggressive in seeking grants to assist in our efforts to purchase and maintain future open space.

An even greater impact to the preservation of open space is when a landowner considers contribution of some or all of their property to Chadds Ford Township. Another option landowners may want to look into is a conservation

easement on all or a portion of their property. The Township is grateful to all landowners who have assisted in the preservation of such open space.

One such landowner is Sandra Baldino, who owned 78 acres on Oakland Road and worked together with Chadds Ford Township Supervisors, North American Land Trust (NALT), Mount Cuba Center, Delaware County and more to preserve her property. It is now the beautiful Brinton Run Preserve. Sandra, by selling her land to NALT left behind this beautiful legacy for Chadds Ford Township residents to enjoy for many years to come.

As a governmental entity we cannot stop landowners from selling to developers or prevent developers from seeking out Chadds Ford Township. However, we can take steps to decrease the impact of development by preserving land before it is set for development. All of us, not just the Supervisors have a vested interest in maintaining the beauty of Chadds Ford Township that we all enjoy!
